FISCAL YEAR 2021 ANNUAL REPORT

FY 2021 Highlights

- Applied for and granted almost 2.2 million dollars in federal grants that will be received over the next four years. These resources will allow for increased overdose prevention and a recovery-to-work program.
- Continued the Federally funded State Opioid Response (SOR) Grant; SOR supports Eastern Ohio Correction Center and Family Recovery Center to increase availability of Medication Assisted Treatment (MAT).
- Worked in collaboration with many County agencies including Jefferson County Board of Developmental Disabilities, Jefferson County Department of Job and Family Services, and the Jefferson County Educational Service Center to strengthen children's behavioral health services. Specifically,
 - Sponsored PAX Programs to assist teachers and parents with encouraging positive behaviors in children in the classroom and home.
 - Participated in Engage Program to assist Multi-System youth and their families.
 - Funded the start-up of Intensive Home-Based Treatment (IHBT).
 - Continued support of Prevention and Educational programming in all Jefferson County School Districts.
 - Implemented the Multi-System Adult Wellness Project with Coleman Health Services.
- We are pleased to report that the United Prevention Partnership received the Federal Drug Free Communities Grant which will fund up to 10 years of drug prevention efforts in Jefferson County.
- The Crisis Stabilization Unit located at Trinity West and operated by Coleman Health Services awaits final licensure by the State. Once licensed this unit is expected to be an excellent resource for Jefferson County.
